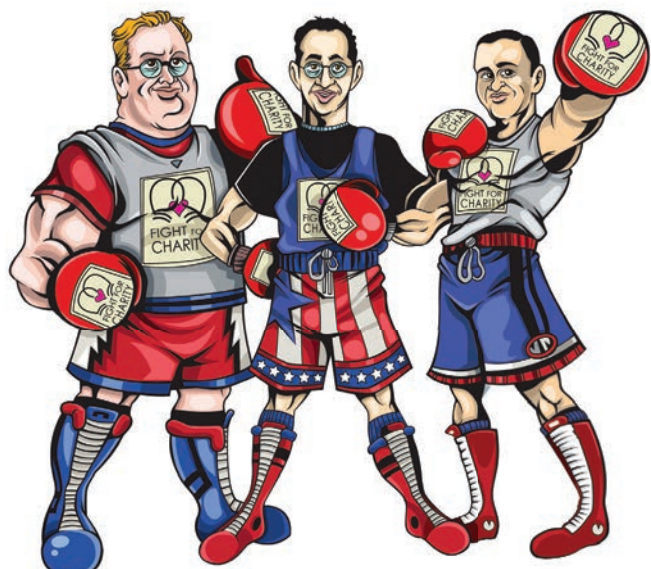

After growing up in Levittown, he raised his four children in Mt. Sinai. He currently resides in Woodbury.

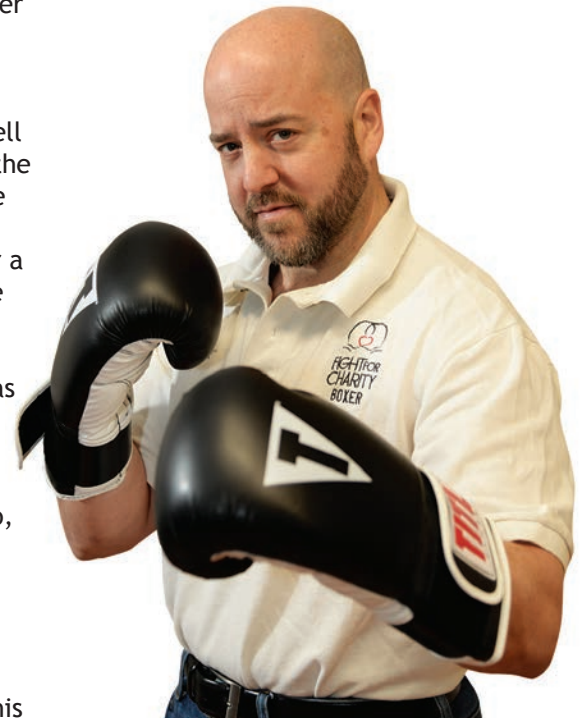


Travis “The Eagle” Buonocore

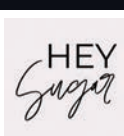
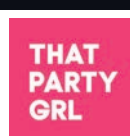

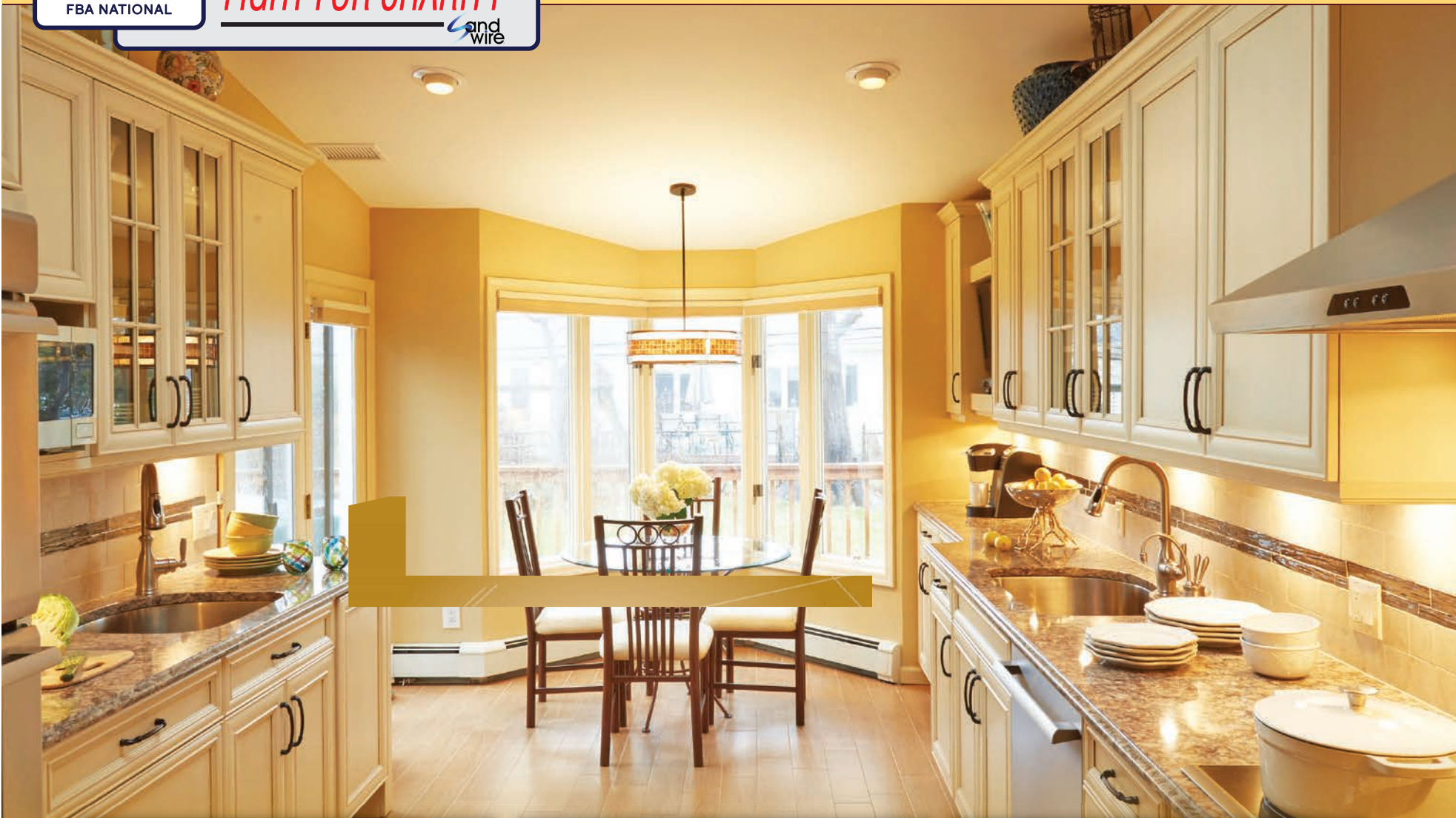

Jennifer lives in Rockville Centre and is married with two sons, Liam and Keegan.

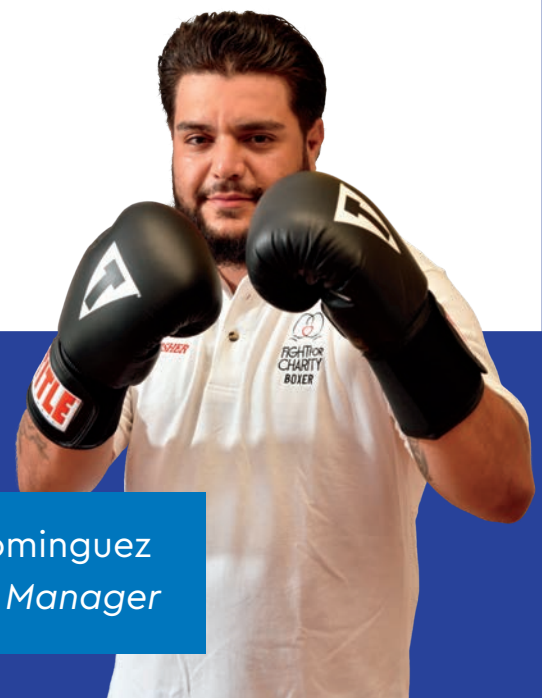
