



Sammy Chu serves as CEO of Edgewise Energy, a NY based clean energy development firm, and President of Caltech Electric, an IBEW signatory electrical contracting firm. Edgewise Energy developed and manages one of the largest community distributed generation projects in the country under the Community Power Long Island banner and are saving Long Islanders more than \$100,000 monthly on their electric bills while providing significant climate benefits.

Chu previously served in the administration of Suffolk County Executive Steve Bellone as Chief of Staff and as commissioner of the county's Department of Labor, Licensing & Consumer Affairs. He was the lead county official in the aftermath of Superstorm Sandy, tasked with coordinating response and recovery.

Chu serves as a board member for several non-profit agencies, including the New York League of Conservation Voters, the EAC Network, and the Long Island chapter of the US Green Building Council. Chu also serves as a trustee of Molloy University and was appointed by Governor Kathy Hochul to serve on the board of the Metropolitan Transportation Authority.

In his free time, Sammy trains and competes as a powerlifter. He is a former US Powerlifting Association masters national champion and holds world, national, and state records for his competitive class.



After volunteering at the 2023 Fight for Charity, I was asked If I would like to participate as a boxer in the 2024 event. My response was an enthusiastic "no!". Life is good. Getting punched in the face wasn't high on my list of goals for this year. So what was the catalyst to get me from the sidelines to the ring?

The good old mid-life crisis played a role. The fifth time I was asked to participate happened to be the same month as my 49th birthday. As a father of six children - I felt the need to do something that I hoped would inspire them to take action in their own lives, whether now or in the future. The idea that it is never too late in life to challenge yourself, step in to the ring and do something big. And like Rocky Balboa said, "it ain't how hard you hit... it's how hard you can get hit and keep moving forward."

But the biggest reason is my friend Jonas. LT Jonas M. Panik, USNR, was my Naval Academy classmate and teammate. He was working as a naval intelligence officer at the Pentagon, and was killed in the terrorist attacks of September 11th, 2001. He was 26 years old on 9/11. Not a day goes by I don't think of my friend. Jonas would never back down from a challenge, and his courage is exemplary of so many of the men and women in our Armed Forces. I fight to honor the memory of my good friend Jonas, and all who have ever put on the uniform to protect our way of life.
